Change Healthcare Cyberattack

On February 21, 2024 Change Healthcare was subject to a cyberattack, impacting pharmacies & patients nationwide

Pharmacy Switches, Change Healthcare, & Patient Access

1 A pharmacy switch is a type of software backbone for Rx processing

Switches support Rx adjudication, enabling pharmacies to transmit claims to insurance companies and process pharmaceutical coupons for patients in real-time



2 The largest switches are RelayHealth and **Change Healthcare**

As of 2021, some online sources attribute 25% of all Rx switch traffic in pharmacies to Change Healthcare¹



3 The latest cyber attack is catastrophic for patients



This blackout period is impacting:

- 1. Distribution: Patients' ability to access medicines AND
- 2. Access: Patients' ability to afford medicines²

Potential Solutions are dependent on the product and extent of the impact



Challenges: Short term solutions may not be as generous for the patient, may be more costly to manufacturers, and may present risk. Considerations for implementing a short-term solution include: existing programs, current distribution model, cost, ability to create awareness, and risk

Set up agreement with pharmacy partner that ships directly to patients	Develop a new copay program with an alternative adjudication partner Given urgency, program design will likely need to be basic and may not fully support all patients (e.g., target copay & maximum offset)	
Support patients to find alternative pharmacy through HUB	Activate other switch-based point of service program (e.g., eVouchers)	Work directly with specialty pharmacies to ensure patients maintain affordable access

Provide free good to impacted patients until networks disruption is resolved

Implications

Product switching may have lasting effects

During this period of disruption, HCPs may switch patients to new medicines and not switch them back. Accordingly, manufacturers whose coupon programs do not use Change Healthcare may have a competitive advantage



There is currently no time-frame for when Change Healthcare will return to full operational capacity. During this period, manufacturers must implement solutions to offset therapy disruption and patient cost

3 Healthcare systems are more fragile than ever before



In 2023, there were 46 hospitals that were affected by ransomware, up from 25 in 2022, with more than 30 already in 2024³ Longer-term contingency plans should be developed to mitigate future risk
